#### 2. JOB SUMMARY

This role reports primarily to the Gippsland Fire Management Forester as part of the silviculture team. Play a role in the Gippsland Region in plantation management and firefighting, along with a range of other activities to support the business. As a small team, we value teamwork, communication, high standards of work and a proactive attitude.

## 3. KEY ACCOUNTABILITIES AND DUTIES

- Undertaking plantation maintenance tasks such as woody and noxious weed control, track maintenance and clearing culverts
- Undertaking log audits, animal damage and survival assessments
- Operating and maintaining brush cutters, chainsaws and pole saws
- Contributing to a safe workplace and the health and safety of others
- Undertaking fire protection works and firefighting duties

#### 4. KEY SKILLS AND ATTRIBUTES REQUIRED

- Good communication and problem solving skills
- Ability to follow instructions and interpret work documentation
- Demonstrated ability to work safely, in a team and without direct supervision
- Chainsaw qualification of Trim and Cross Cut Felled Trees with the ability to progress to Basic Falling accreditation is preferable but not mandatory.
- Motivation and integrity
- Be willing to participate in a regular weekend standby roster

- A willingness to participate in and develop field based operational tasks in all weather conditions and terrain
- Experience with the safe handling and use of chemicals ChemCert Accreditation and ACUP is preferable
- Level 2 First Aid is preferable
- Basic computer skills familiarity with Outlook, Excel, Word and Mapping programs will be well regarded
